Winter Carnival Update

11. Chaplaincy Committee Report

General overview:

- Chappy Week has been a focus this month
- An increase in referrals has led to a review of this process in consultation with the Student Welfare Team.

Core functions:

1. Social and Emotional Support (Pastoral Care)

- A number of students are currently accessing one on one support
- Due to a lunch time girls club being run I have not run Chit Chat this term
- I will develop a referral form to be completed by teachers/parents wanting to refer students for one on one pastoral care, this form will be shared with SWT to determine best way forward to provide care for referred students. This will avoid double ups and ensure the service is being utilized in the best possible way, and in partnership with other care providers in our school. Students may continue to self-refer.

2. Educational Support

- Chappy attending Year 5 camp Wednesday/Thursday of Week 8. I will work Tuesday only for Pancake breakfast due to 2 days on camp in Week 8.

3. Community Development (including donor nurture, community and church connections etc)

- As part of Chappy Week I invited local ministers to an afternoon tea – 5 churches responded and 3 attended (Brisbane Pentecostals, St

Peter's Catholic, New Heart Baptist Rochedale, Our Saviour Lutheran Rochedale, Grace Bible Church). Those in attendance were very interested in supporting Chaplaincy/seeking more information on volunteerism, representation on the Chaplaincy Committee, donor support. Chaplaincy will support local faith communities by promoting their programs and events to families.

4. Extra- Curricular Activities
 - Triple P Positive Parenting Program has almost concluded, 5 families participating with positive results!
 - Chappy Week – Tuesday 22/5 and Thursday 24/5 were packed with activities for children across all year levels. Instead of Chaplaincy fundraising this year I elected to invite families to donate towards a pantry for families in need. Staff won the inaugural Staff v Students Chappy Week basketball game.
 - Under 8s – Chappy will do face painting, tea and coffee for parents in Chappy room, fruit break on grass outside Chappy Room for children (fruit will be provided/donated through Chaplaincy). Volunteers to help with face painting appreciated!
 - Pancake breakfast Tuesday Week 8 – 8am. Volunteers needed from 7:30am please. Will add tea and coffee for parents.
5. SUQId team Contribution
 - I attended in-service on 16/5 at Nerang – important information re Government funding was presented. The school will need to reapply for funding for Chaplaincy by the end of the year. I would like P&C support/endorsement to explore ways of increasing our donor base with a view to increasing our service towards 3 days a week for 2019.
 - 26/5 Spin Off challenge – this year I will be riding to support a fellow Chappy, with a view to having a RSSS team in 2019.
